The investment objective of the Emerging Markets Core Equity 2 Portfolio is to achieve long-term capital appreciation.

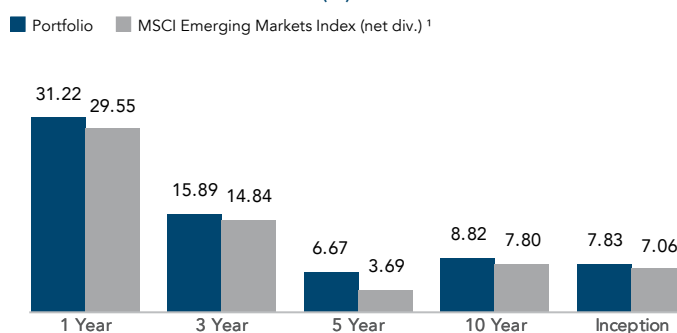
