



In the US, Large Cap is defined as approximately the largest 70% of market capitalization, Mid Cap the next 20%, and Small Cap the smallest 10%. In developed markets except the US, Large Cap is defined as approximately the largest 70% of market capitalization in each country or region, Mid Cap the next 17.5%, and Small Cap the smallest 12.5%. In emerging markets, Large Cap is defined as approximately the largest 70% of market capitalization in each country or region, Mid Cap the next 15%, and Small Cap the smallest 15%. Designations between value and growth are based on price to book ratios. Value is defined as the 50% of market cap with the lineyes price to book ratios by size category and growth is the highest 50%. Profitability is measured as operating income before depreciation and amortization minus interest expenses escaled by book. High profitability is defined as the 50% of market cap with the highest profitability by size rategory and low profitability is the lowest 50%. RETIS, Utilities, and Ottilities, and other than the capital profitability is defined as the 50% of market cap with the highest profitability is the lowest 50%. RETIS, Utilities, and Ottilities, and Ottilities, identified by GICS code, and stocks without size, relative price, or profitability metrics. Weights may not total 100% due to rounding. GICS was developed by and is the exclusive property of MSCI and S&P Dow Jones Indices LLC, a division of S&P Global.

Credit rating agencies Moody's Investor Service, Fitch Ratings, and Standard & Poor's Corporation rate the credit quality of debt issues. For reporting purposes, Dimensional generally assigns a composite rating based on stated ratings from Nationally Recognized Statistical Ratings Organizations ("NRSROs"). For example, if Moody's, Fitch, and S&P all provide ratings, Dimensional assigns the median rating. In certain instances, such as Pre-Refunded Municipals and US Treasury and Agency securities, Dimensional will assign the internal Dimensional rating. The internal Dimensional rating can only be as high as the highest stated credit rating from an NRSRO.
